Introduction

Biennial Review of Quinnipiac University Alcohol and Other Drug Programs - Fall 2020 to Spring 2022

The Department of Education requires institutions to conduct an internal biennial review every 2 academic years. The purpose of the biennial review is (1) to determine the effectiveness of, and to implement any needed changes to, the AOD prevention program and (2) to ensure that campuses enforce disciplinary sanctions for violating standards of conduct.

The biennial review also must include a determination as to:

- The number of drug- and alcohol-related violations and fatalities occurring on the campus or as part of any activities that are reported to campus officials; and
- The number and types of sanctions the IHE imposes on students or employees as a result of such violations or fatalities.

In addition to the biennial review, institutions are required to send formal communications to the community in compliance with the Drug-Free Schools and Campuses Regulations (34 CFR Part 86) of the Drug-Free Schools and Communities Act (DFSCA). The purpose of the communication is (1) to certify that it has implemented programs to prevent the abuse of alcohol and use or distribution of illicit drugs by students and employees, both on its premises and as a part of any of its activities. At a minimum, each institution of higher education must annually distribute the following in writing to all students and employees:

- Standards of conduct that clearly prohibit the unlawful possession, use or distribution of illicit drugs and alcohol by students and employees;
- A description of the legal sanctions under local, state or federal law for the unlawful possession or distribution of illicit drugs and alcohol;
- A description of any drug or alcohol counseling, treatment, or rehabilitation or re-entry programs that are available to employees or students; and
- A clear statement that the institution will impose sanctions on students and employees and a description of those sanctions, up to and including expulsion or termination of employment and referral for prosecution, for violations of the standards of conduct.

In acknowledgment of its legal obligation to conduct a biennial review in compliance with the Drug-Free Schools and Communities Act, Quinnipiac University authorized an administrative review to be conducted to determine if the institution fulfills the requirements of the previously mentioned federal regulations.

The vice president of student affairs and dean of students or designee is responsible for completing the biennial review. Policies and procedures for students and employees regarding standards of conduct involving alcohol and drugs are available in both the Student Handbook and Employee Handbook.

Institutional Community Resources

CARE: The Community, Assessment, Response and Evaluation (CARE) Team is committed to the safety and well-being of our community through proactive, coordinated and deliberate approaches by identifying, assessing, managing and reducing any student interpersonal or behavioral concerns. The CARE Team is a partnership of various university offices that is supported by the Office of the Dean of Students.

By partnering with members of the Quinnipiac University community, the CARE Team works to promote student well-being and success. CARE referrals are submitted by faculty, staff, students and community members. Referrals range in topics including helping a student during difficult times such as the passing of a loved one, when a student needs support for their physical, emotional, mental, spiritual or financial health, and/or when experiencing social challenges with roommates, friends and/or peers.

Counseling Services: This office provides access to care for students who may be seeking help for emotional distress. The goal is to assist students through brief therapy while addressing concerns that may be negatively impacting academic performance or the student's quality of life within the university community. Counselors and a part-time psychiatrist are a resource for students struggling with stress, anxiety, depression, relationship problems, eating disorders and alcohol or drug abuse. Other common

problems include difficulty making decisions, low self-esteem, procrastination or the stress of leaving home while adjusting to college life.

Counseling staff members also are available to assist any student who has been affected through physical or sexual violence or who may be grieving the loss of a loved one.

The Office of Student Conduct and Community Standards: The Office of Student Conduct and Community Standards promotes a safe and inclusive university environment by helping students and student organizations engage positively with the university community, define their values, and demonstrate responsible behavior on and off campus.

Using the Student Code of Conduct as a foundation for community standards, the office provides resources and education to students and their families, and staff and faculty. The Director of the Office of Student Conduct and Community Standards, along with other conduct professionals, helps students think critically about their behavior and the effect it is likely to have on the community, identify the impact of their personal decisions, and define their personal values.

The Office of Student Conduct:

- · Advises and assists parties involved in the student conduct process
- Trains and advises student conduct professionals and student leaders
- Reviews decisions of the code of conduct process
- Maintains all student disciplinary records
- Collects and disseminates research and analysis concerning student conduct

Human Resources: This office offers support to faculty and staff through an Employee Assistance Program. The program provides confidential and voluntary counseling referral services free of charge to all faculty and staff at the institution and members of their family household.

The Department of Public Safety: The Quinnipiac University Department of Public Safety is committed to protecting and preserving the quality of life for all members of the Quinnipiac University community by providing enforcement, prevention, intervention and education through the delivery of professional campus safety services. Public Safety officers carry out their duties with P.R.I.D.E.: professionalism, responsibility, integrity, dedication and excellence.

The Department of Public Safety is comprised of approximately 60 officers, the majority of whom have substantial prior law enforcement experience with federal, state and local law enforcement agencies. The

officers are trained in emergency first aid and respond to all medical emergencies with medical and fire department personnel. In this role, Public Safety officers are often the first responders to calls involving intoxicated students. Public Safety documents incidents involving intoxicated students and routinely refers such incidents to the Office of Student Conduct and Community Standards, the CARE Team and Health Services. Public Safety officers are key partners with Health Services, Residential Life and Student Affairs in ensuring students engaging in the unsafe use or abuse of alcohol and/or drugs are cared for, counseled and educated to the consequences of substance abuse.

Public Safety officers engage in consistent and vigilant patrols of shuttle stops, parking lots and ride share lots on evenings and weekends. Shuttle stops, parking lots and the Hogan Lot, where ride share vehicles pick up and drop off students traveling off campus, are subject to enhanced patrols for students who are dangerously intoxicated and may require medical assistance and/or behavioral intervention. Self-reported alcohol abuse disclosed by students in surveys routinely highlights the ease with which underage student drinkers can obtain alcohol off campus. Accordingly, Public Safety maintains relationships with local law enforcement agencies to identify establishments serving alcohol to underage Quinnipiac University students with an aim of pursuing law enforcement and code enforcement action in the respective jurisdictions.

In compliance with the Jeanne Clery Disclosure of Campus Security Policy and Campus Crime Statistics Act, commonly known as the Clery Act, the Department of Public Safety maintains daily crime logs. The crime logs, which are available online to the Quinnipiac University community and to the public, include reports of liquor and drug law violations reported to the Department of Public Safety and to Student Affairs.

The Department of Public Safety also generates the Annual Security and Fire Safety Reports (ASFSRs) for the Mount Carmel, York Hill and North Haven campuses on an annual basis. The ASFSR is also publicly available online. The ASFSR provides a comprehensive summary of crime statistics, security policies and safety programs as required by the Clery Act. In relevant part, the ASFSR provides a calendar year comparison of drug and alcohol arrests and disciplinary referrals to the Office of Student Conduct and Community Standards. The 2022 ASFSR, which will report upon drug and alcohol disciplinary referrals and arrests for the 2021 calendar year, will be available online October 2022. The 2021 ASFSR, which reports the calendar year 2020 drug and alcohol statistics for the Quinnipiac University campuses, includes historical statistics for 2018 and 2019. Institutional Research and Culture

All new students in 2020-2021 and 2021-2022 completed eCHECKUP TO GO, an evidence-based online alcohol education program. eCHECKUP TO GO was also assigned as a sanction for students found responsible for underage alcohol possession/consumption. Beginning Fall 2022, Quinnipiac University is assigning the following 3rd Millennium Classrooms prevention modules to all new students: Alcohol Wise, Cannabis Wise, Other Drugs. These modules are designed as educational prevention modules for new students.

eCHECKUP TO GO generated useful data about the alcohol use patterns of incoming Quinnipiac students. This data is useful when establishing new policies and linking retention efforts surrounding alcohol.

Additionally, these data have been shared with various institutional partners. In 2020-2021, 1,996 students took eCHECKUP TO GO, and in 2021-2022, 1,055 students took eCHECKUP TO GO.

Student self-reported data can be found in Appendix A for 2020-2021, and Appendix B for 2021-2022.

The university has very positive outcomes from its Student Conduct Process. For example, students found responsible for violating university policies have a very low repeat offender percentage. During the 2021-2022 academic year, students found responsible for a policy violation had a low 2.1% likelihood of violating the same policy again.

Additionally, first-year students who participated in a student conduct meeting were retained at the university into their sophomore year at a higher rate than their peers who did not participate in a student conduct meeting. This speaks to the intentional and educational philosophy of the process.

Prevention Training for Professional and Paraprofessional Staff

Annually, members of our university community are trained on alcohol and other drug policies by staff within the Office of Student Conduct and Community Standards and/or the dean of students. These topics include policy enforcement, identifying intoxicated students, treating intoxicated students and Quinnipiac University student trends with alcohol use. Groups that are trained, as a whole or in part, may include but are not limited to:

- Office of Campus Life Orientation Leaders
- Office of Health and Wellness Nurses, EMTs, administrative staff, mental health counselors
- Department of Public Safety Public Safety officers
- Office of Residential Life Residence Hall Directors, Resident Assistants
- Office of Fraternity & Sorority Life Social Event Managers, Chapter Executive Board Members, Chapter Social Chairs
- Faculty Senate Student Affairs Committee

Enforcement

The Department of Public Safety and Office of Residential Life are the two departments primarily responsible for documenting policy violations on campus. The university also receives referrals from the local police, most frequently from Yale University Police, New Haven Police and Hamden Police. Law enforcement referrals are sent through the Quinnipiac Department of Public Safety.

The Office of Student Conduct and Community Standards oversees distribution and management of student conduct cases.

There are several Student Affairs staff members who hear conduct meetings, most often from the Office of Student Conduct and Community Standards and the Department of Residential Life.

Students who are too intoxicated to remain on campus are sent to the emergency room. Students requiring medical transport to the hospital attend a series of meetings with university officials. During the transport, a staff member or Public Safety officer notifies the student's emergency contact immediately. Once a student is released from the hospital, a university staff member from the Office of the Dean of Students schedules an educational meeting with the student. Students are required to meet with the CARE Team chairperson and then attend a student conduct meeting for the intoxicated behavior if appropriate.

The data below represents the total number of students transported to the emergency department for alcohol or other drug-related intoxication for each year during the reporting period.

Summary of Future Recommendations

In March 2020, the COVID-19 pandemic impacted campus operations, and this persisted through the 2020-2021 academic year as well as the 2021-2022 academic year. COVID-19 changed how higher education and Quinnipiac University served our students. Many student conduct meetings or CARE meetings related to alcohol or other drugs took place via Zoom or telephone during the 2020-2021 academic year but returned to in-person meetings for 2021-2022. Students prefer to meet in person and in Fall 2022 all meetings will be in person except in circumstances where an in-person meeting is not possible or may be unsafe as during the 2021-2022 academic year.

For this entire reporting period, the university has made the decision to keep the Prevention Educator position unfilled at the university.

The following goals are being addressed by the university as outlined in the 2018-2020 biennial review:

- Quinnipiac University should create and implement a university-wide bystander intervention model that would incorporate efforts to reduce dangerous alcohol/drug use, sexual misconduct, bias, discrimination and harassment. Many institutions similar to Quinnipiac University develop a campus-wide curriculum aimed at harm reduction through similar programs. This project is underway and is being led by the Office of Student Conduct and Community Standards. In preparation for the Fall 2021 semester, the Office of Student Conduct and Community Standards created bystander intervention trainings and informational fliers and highlighted the importance for bystander intervention at new student orientation trainings and trainings for other students and student leaders.
- Develop a training program for students who wish to live off campus to reduce the risk associated with off-campus gatherings involving alcohol and/or other drugs. This project was led by the Office of Student Conduct and Community Standards and these trainings have been delivered ahead of the Fall 2020, Fall 2021, and Fall 2022 semesters.
- Establish a medical amnesty policy that promotes a culture of care and prosocial bystander behavior. This project was led by the Office of Student Conduct and Community Standards, and a new "Promoting Responsible Action in Medical Emergencies" policy was created for Quinnipiac University, encouraging students to call for help any time they are worried about the intoxication of themself or any other student. Under the policy, the university will address these cases through an educational process parallel to the student conduct process. The intent of this policy is to ensure students who need help get help and are not deterred due to the fear of a conduct meeting.

For the coming years, the following recommendations are suggested:

- For Fall 2022, the Office of Student Conduct and Community Standards identified, secured funding for, and launched online prevention education modules for all incoming first-year students on the topics of alcohol safety, cannabis safety and other drug safety. This initiative is a significant improvement over the university's previous use of eCHECKUP TO GO for this purpose. Quinnipiac University should continue to fund this invaluable initiative.
- Quinnipiac University should hire a full-time prevention and wellness educator to join the Student Affairs division. This position would ideally engage in proactive education to reduce the use and secondary harms of alcohol and other drugs and could facilitate post-incident educational conduct meetings.
- Quinnipiac University should leverage the resources and expertise of Hartford HealthCare to further advance prevention efforts at the university.

• Quinnipiac University should establish a committee to address alcohol and other drug use and abuse. This committee would be comprised of representatives from student affairs, public safety, Hamden police, Hartford HealthCare
