#### Part-Time Schedule

The part-time JD program usually takes four academic years to complete. During the first year, most students take evening classes three nights per week. Starting in the second year, you can build your schedule from day or evening classes, or a combination of both.

A seven-week evening summer session can help you speed up your time to graduation or fulfill core elective credits, freeing up your schedule during the academic year.

Part-time JD students have the option of switching to the full-time program after their first year so they can graduate in three years.

# **Third Year and Fourth Year**

# **Admission Requirements**

- Applicants must have earned a bachelor's degree from an accredited college or university and have completed the Law School Admission Test (LSAT) and writing sample.
- The two most important criteria for selection are undergraduate scholastic record and LSAT score. The Faculty Admissions Committee also considers factors such as advanced degrees, work experience, extracurricular activities, and writing skills.
- We welcome applications from students of color, nontraditional students, and all students who add to the diversity of our law school because we believe that diversity enhances our dynamic learning environment.
- All applicants must submit their application and supporting materials using the Law School Admissions Council's Credential Assembly Service (LSAC and CAS).
- Applications are considered on a rolling basis, with priority given to those submitted by March 1 for fall admission.

# Financial Aid and Scholarships

Quinnipiac Law offers a number of scholarships and grants in addition to assistance with loan options:

- Admitted students are automatically considered for merit scholarships. Scholarships include Distinguished Scholar Awards (diversity-based awards), Emergency Response Personnel Scholarships, and Military Appreciation Scholarships.
- Approximately 95% of all enrolled students receive funding through scholarships and/or grants.
- Tuition for the 2022–2023 academic year is approximately \$36,900 for part-time students, based on an average of 10 credits per semester at \$1,845 per credit. Tuition for students in their first year is \$35,055 (based on 19 credits).
- Students may incur additional expenses for food, transportation, and books.



# Quinnipiac School of Law Center
